The College will issue Statements for the Annual Tuition Fees and Levies to families at the end of January prior to commencement of the new school year.

The Annual Consolidated Levy is a fixed charge levied to cover costs such as annual camps and retreats, the College Notebook Program, educational subscriptions, and Valedictory ticket (Year 12 students only).

The Family Capital Levy covers the ongoing facilities development and associated building programs, as well as general maintenance and site costs across our three campuses.

Costs related to extra-curricular non-compulsory activities or events are not included in this schedule.

### Other Charges

#### Application Fee

A payment of \$65 (incl GST) is payable when submitting the standard Application for Enrolment form. This fee is non-transferable and non-refundable.

#### Enrolment Fee

When an offer of a place at De La Salle College is accepted a payment of \$300 is required. This fee is non-transferable and non-refundable.

#### Private Music Program

Private music lessons are available as an option to students and as such attract an additional fee. Instruments may be hired (at an additional cost) if required. Payment of the semester fee is required on registration for a student to participate.

#### VET/VCE Vocational Major (VCE/VM) Charges

VET course fees are dependent on the option/s undertaken by the student. For the courses offered by the College, fees of up to \$3,500 are covered. For any fee in excess of \$3,500 the difference is payable by the family.

## Discounts

### Early Payment Discount

A discount of \$375 per student will be granted when the full amount of Annual Tuition Fees and Levies are paid to the Finance Office by close of business on the 28th of February each year.

Where individual parents/guardians/carers are responsible for only a portion of the Annual Tuition Fees and Levies then that same proportion should be applied to the discount.

### Sibling Discounts

This discount is applied to the Annual Tuition Fee only. The discount is not applied to the Consolidated Levy.

- Second child: 15%
- Third child: 20%
- Subsequent child/ren: 40%

### Old Collegians Rebate

A rebate will apply on entry to families of Old Collegians (grandfather/father/brother/uncle) as a one off \$500 rebate per child applied on entry for the first year only. A credit will be applied against the tuition fee account of the individual student in the first year's fee statement.

### CSEF Discounts

Families who hold a current Centrelink pension or Health Care Card and qualify for the Camps, Sports and Excursions Fund (CSEF) will receive an allowance from the State Government.

## Payment Options

### Scheduled Payment Plan Options

- **Credit Card - Regular monthly payments**  
February to November - 10 instalments: 15<sup>th</sup> of the month (or nearest bank trading day)
- **Direct Debit - Regular monthly payments**  
February to November - 10 instalments: either the 14<sup>th</sup> or the 28<sup>th</sup> of the month (or nearest bank trading day)

### Non-scheduled Payment Plan Options

- **Payment in Full - Single payment on/before the close of business on 28<sup>th</sup> of February each year**  
A discount of \$375 per student is applied.

### Finalising Fee Accounts by the End of the School Year

The College expects that all family accounts are paid in full by 30<sup>th</sup> November to ensure that the College is able to meet its financial obligations to both staff and external suppliers. The College is unable to extend credit terms to families.
