



De La Salle College Malvern Parent/Guardian/Carer/Visitor Code of Conduct

De La Salle College Malvern is a College which operates with the consent of the Catholic Archbishop of Melbourne and is owned, operated and governed by Melbourne Archdiocese Catholic Schools Ltd (MACS). This Code of Code is created with reference to De La Salle College Enrolment Policy and De La Salle College Enrolment Agreement. Parents/Guardians/Carers are expected to read, acknowledge, and comply with the Code of Conduct for the student's enrolment to be accepted.

Purpose

De La Salle College is committed to ensuring a respectful learning environment that is safe, positive, and supportive for all students, staff and visitors of the College.

It is the intention of De La Salle College to provide clear guidelines to all parents and visitors regarding the conduct expected of them while in a school environment, or at College related places, engaging in College-related activities or representing the College. Parents/guardians/carers and visitors are expected to uphold the College's core values at all times.

Scope

This Code of Conduct applies to all De La Salle College parents/guardians/carers and visitors to the College and College related places. The application of this code is not limited to the College site and school hours. It extends to all College-related activities and events (including, but not limited to, sporting events, online activity, visiting or representing the College.

Principles

This Code of Conduct is based on the following principles that everyone at De La Salle College:

- has the right to be safe
- has the right to be treated with respect and be valued even in disagreement
- has the right to participate within a secure environment without interference, intimidation, harassment, bullying, discrimination or any harmful, threatening or abusive behaviour
- is encouraged to be respectful, polite, courteous and considerate of others
- has the right to be supported and challenged as ongoing learners.

Expected conduct and bearing of all parents/guardians/carers/visitors

It is expected that every parent/guardian/carers/visitor will:

- uphold the College's core beliefs and values
- behave in a manner that does not endanger the health, safety and wellbeing of themselves or others
- abide by all health and safety rules and procedures operating within the College and other locations at which they may visit while representing the College
- ensure that their actions do not bring the College into disrepute
- respect College staff and accept their authority and direction within the exercise of their duties at the College
- observe all College rules as required
- strictly adhere to the College's policies and procedures as required
- behave with respect, courtesy, and consideration for others
- refrain from all forms of bullying and harassment
- refrain from any form of verbal insult or abuse and from any form of physical abuse or intimidation
- refrain from activities, conduct or communication that would reasonably be seen to undermine the reputation of the College, employees or students of the College, including activities on social media
- respect College property and the property of staff, contractors, volunteers and other students
- not be intoxicated by alcohol or under the influence of illicit drugs or other substances harmful to health while visiting the College site, attending College functions or engaging in College-based activities
- use the College's Complaints Handling Policy to seek resolution for any problems that arise and accept the College's procedures for handling matters of complaint.

Unacceptable conduct

Unacceptable conduct includes, but is not limited to:

- touching, handling, pushing or otherwise physically or sexually engaging with students, children or others in a manner which is not appropriate and may endanger the health, safety and wellbeing of that person
- any form of physical or verbal violence including fighting, assault or threats of violence or behaviour that is otherwise harmful, threatening or abusive
- approaching a child that is not your own with a view to disciplining that child for their behaviour. Such matters are only to be dealt with by College staff
- approaching other College parents to resolve issues arising between students at school. Such matters should be referred to College staff
- any form of cyber bullying or cyber abuse that is directed towards the College, staff members, students or parents or any member connected to the College
- any form of threatening language, hand gestures or conduct
- language or conduct which is harmful, threatening, abusive or likely to offend, harass, bully or unfairly discriminate against any student, employee, contractor, volunteer or other
- corresponding or communicating with College staff in a manner which is unreasonable (including for example, via email or app's) in terms of the frequency or volume of communications, or the nature or tone of such communications including shouting or swearing, either in person or on the telephone
- theft, fraud or misuse of school resources
- racist or sexist comments
- the use of inappropriate or profane words or gestures and images
- visiting the College, attending social, sporting or other functions while intoxicated by alcohol or under the influence of illicit drugs or other substances harmful to health
- smoking on the College premises or within the immediate environs of the College
- claiming to represent the College in any matter without explicit permission from the College Principal to do so
- damage or violation of possessions/property.

Breach of the Code of Conduct

Parents/guardians/carers are, as a condition of enrolment, expected to read, acknowledge, and comply with the De La Salle College Enrolment Agreement, De La Salle College Parent/Guardian/Carer/Visitor Code of Conduct (**Code of Conduct**), and relevant College policies.

Parents/guardians/carers who breach this Code of Conduct or Enrolment Agreement will be contacted by the Principal. Appropriate action, which may include limiting and reducing access to College grounds, attending College functions or College-based activities or, setting mandatory parameters around methods and timing of communication, or imposing an Immediate or Ongoing School Community Safety Order is at the discretion of the Principal and other authorised persons.

Should any parent/guardian/carer:

- (a) repeatedly breach the terms of the Agreement, Code of Conduct, and/or relevant school policies (after the parent/guardian/carer or the family collectively, has been warned that any further breach may result in a termination of enrolment); or
- (b) engage in conduct on a single occasion which constitutes a serious breach of the Code of Conduct and/or relevant school policies (involving for example, conduct which poses a serious risk to staff or student health and safety), the circumstances may result in a termination of their son's enrolment.
- (c) A termination of enrolment may also occur where any parent/guardian/carer has engaged in conduct on a single occasion which constitutes a serious breach of the Parent/Guardian/Carer Code of Conduct and/or relevant school policies (involving for example, conduct which poses a serious risk to staff or student health and safety.) In these circumstances, it will not be necessary for a warning to be given before consideration is given to termination of enrolment.

A decision to withdraw or terminate the enrolment of a student may only be made by the Director, Learning and Regional Services upon consideration of the following:

- the view of the Principal of the College
- an objective assessment of all presenting circumstances, including the nature and gravity of the conduct and whether any previous warnings have been provided to the parent/guardian/carer
- the principles of procedural fairness are followed in the decision-making process, including an opportunity for the student and their family/guardians/carers to be heard, all relevant information considered.

Before any final decision as to termination of enrolment is made, the student’s family will be provided with an opportunity to comment on and/or provide any relevant information for consideration in this regard.

In accordance with applicable legislation and the College’s Child Safety and Wellbeing Policy, the police and/or ‘Families and Children’s Services’ within the Department of Families, Fairness and Housing (DFFH), Commission for Children and Young People (CCYP), and/or any other relevant bodies will be informed of any unlawful breaches of this code.

Acceptance of Parent/Guardian/Carer/Visitor Code of Conduct

As part of the enrolment processes at the College, parents/guardians/carers are required to acknowledge this Code of Conduct at the time of enrolment and yearly thereon via the Consent 2 Go platform.

Visitors are requested to acknowledge this Code of Conduct at the time of signing into the relevant College Reception via the sign in portal.
